EXAMPLE OF SAVINGS FOR EMPLOYERS & EMPLOYEES

You can offer your employees a financial bonus, such as a pay rise, or you can give them luncheon vouchers. Take a look at the example below to see which of these two options would work better for everyone.

COMPARE TWO OPTIONS

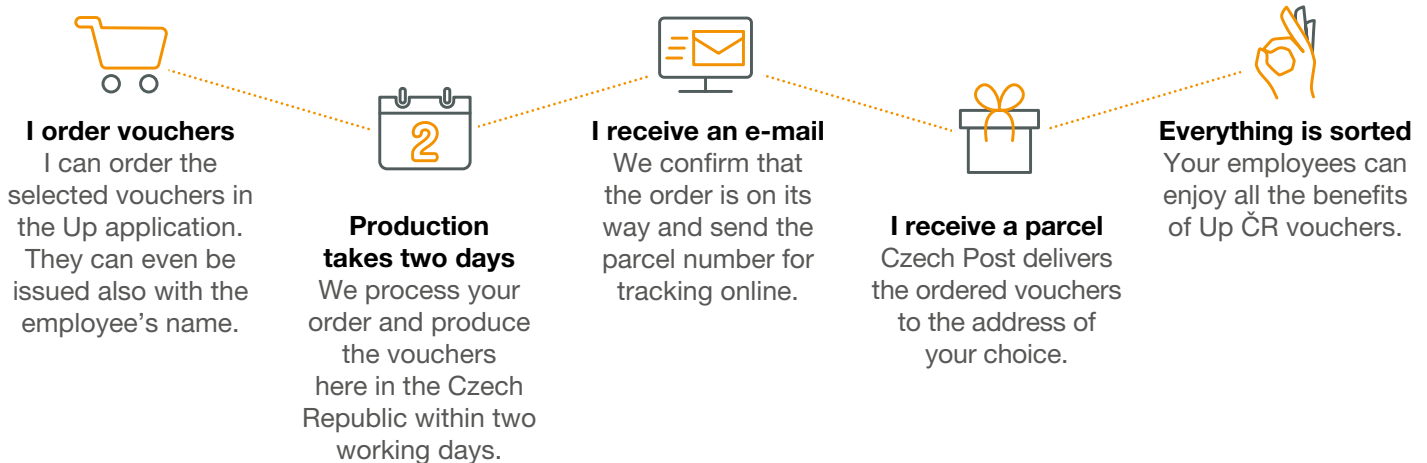
■ salary increase/month for 50 employees

■ 21 meal vouchers/month CZK 137 each

Employer pays for one month:	CZK 79 118	CZK 79 118
Insurance paid by the employer per one month:	CZK 26 900	CZK 0
Total paid by the employer for one month:	CZK 106 017	CZK 79 118
Savings realized by the employer for one year:	CZK 0	CZK 322 799
Employee's annual income increased by:	CZK 14 051	CZK 18 988

The calculation is set at 55% for the employer's share in a meal voucher value and anticipates 21 business days in a month.
