EXAMPLE OF SAVINGS FOR EMPLOYERS & EMPLOYEES

You can offer your employees a financial bonus, such as a pay rise, or you can give them luncheon vouchers. Take a look at the example below to see which of these two options would work better for everyone.

COMPARE TWO OPTIONS ■ salary increase/month for 50 employees 21 meal vouchers/month CZK 194 each CZK 112 035 Employer pays for one month: CZK 112 035 CZK 37 867 Insurace paid by the employer per one month: CZK 0 CZK 149 903 Total paid by the employer for one month: CZK 112 035 CZK 0 Savings realized by the employer for one year: CZK 454 414 CZK 19 897 Employee's annual income increased by: CZK 26 888

The calculation is set at 55% for the employer's share in a meal voucher value and anticipates 21 business days in a month.
