Employer's saving

The tax deductibility of meal vouchers applies to the full value of the meal voucher.



Increase of employee's income

The meal voucher allowance will increase the employee's net income, which is exempt from tax and insurance contributions up to the statutory limit of CZK 129.25.

The meal voucher is the most popular company benefit among employees, 93% of them think so. 75% of employees in the Czech Republic use the employee meal system. 60 000 employers provide their employees with meal vouchers. 1 300 000 employees in the Czech Republic use meal vouchers. The financial saving compared to a payroll payment is almost half the cost for your employees up to the statutory limit. And what about meal vouchers and taxes? For employers, the value of a meal voucher is a fully tax-deductible expense and, up to the statutory limit, is also exempt from insurance contributions.

Example of savings with Up vouchers for employers and employees

Compare two options

salary increase/month for 50 employees

21 meal vouchers/month 235 CZK* each

The employer pays in a month:

CZK 135 713
 CZK 135 713

The employer pays in insurance per month:

CZK 45 871
 CZK 0

The employer pays a total of:

CZK 181 583
 CZK 135 713

The employer saves per year:

CZK 0
 CZK 550 450

The employee's annual income will increase by:

CZK 23 907
 CZK 32 571

*The calculation is set at the employer's 55% share of the value of the meal voucher and assumes 21 working days per month.
